Meeting commenced on September 05, 2008 at 1600 hrs in IACC, 4<sup>th</sup> Floor, PHD House, 4/2 Siri Institutional Area, New Delhi – 110016, office. Larry Coughlin, Co- Chair Industry ACP addressed the members of ACP and discussed the agenda of the meeting.

#### 1. Review the Minutes of last Meeting and Approval

- **a.** Dr. Arjun Singh, Program Director, briefed about ACP member companies response on use of their "Company Logo" in the ACP material for the India Aviation 2008 air show in Hyderabad. The following four companies have responded.

**b.** ACP brochure printing rate for the India Aviation 2008 airshow has been submitted to the ACP Executive Committee for approval. ACP member desires to have a six-pages (tri-fold) brochure. Regarding second meeting with the DGCA, Mr. Venkat Raman stated that request has been sent to the team companies to send the requisite information for finalization of the Terms of Reference (TOR). The second meeting with DGCA will be scheduled once the TORs are finalized.
- Team member companies of this project are requested to send and expedite information required by project team lead at the earliest so that TOR can be finalized before India Aviation 2008 air show.

- Develop Program for CNS Engineers e.g. training, gap in maintenance practices, assessment of CNS infrastructure, calibration, certification and validation of CNS equipment SIS and documentations, etc.
