3. Points of Discussion

Dr. Dinesh Keskar, ACP Co-Chair (Industry) kicked-off the Board meeting and welcomed the ACP members. He emphasized on a number of points to "Take ACP to the Next Level". These included in conducting regular ACP project reviews with Indian government customers as well as detailed project strategy meetings with each project team on a rotation basis. He mooted the idea of inviting speakers in the ACP Board Meeting from Airports Authority of India (AAI), Ministry of Civil Aviation (MCA), Directorate General of Civil Aviation (DGCA) and Bureau of Civil Aviation Security (BCAS) to talk about the ACP and their respective organizations. He further talked about formation of ACP sub-committees in line with the pre-established ACP

domain areas so as to enable greater involvement and decentralized decision making on projects to be taken up. He suggested publishing of an ACP yearly calendar so that all members are made aware well in advance of upcoming ACP deadlines, industry events and so on.

3.1 <u>Dashboard of Projects & Proposals</u>

3.1.1 Project Completed/Underway

Dr. Arjun Singh, Program Director-ACP reviewed the "completed / underway projects". Completion dates and approval dates for various projects were informed to the ACP Board. Overall, ACP is doing well from a projects perspective. Regarding "Projects & Active Proposals with the USTDA," please refer to the four square charts presented in the ACP Board meeting.

3.1.2 Proposals under Processing/Development/Consideration:

a. Technical, Management, & Operational Development Training [TMODT]

TMODT project was submitted in August 2009 to USTDA and returned back for resubmission after additional inputs. Proposal to be resubmitted by new Project Lead (to be finalized).

b. AAI ATCO Manpower Assessment [AAI Cost Share]

This project looks to be on schedule as confirmed by USTDA.

3.1.3 Proposals under Development

a. ATM Processes & Procedures Implementation

This project is a follow-on project of the ATM Training program and the final report has been submitted to Airports Authority of India (AAI). The AAI has re-iterated its interest to get this project underway as soon as possible.

b. Airport Regulatory & Financing Pilot for a Regional Airport

This project is a new proposal and it is follow-on of the high-level roundtable conference held in March 2, 2010 at Hyderabad.

c. Safety Management System Development Plan [DGCA cost Share]

Proposal of this project will be submitted after conduct of the *Global Aviation Safety Roadmapping (GASR) Workshop* to be hosted by the DGCA on June 25 and 26, 2010. Team lead of this project is not yet decided by ACP Board.

3.1.4 Proposals under Consideration

a. AAI CNS Manpower Assessment [AAI cost Share]

This project is follow-on to the ATCO Manpower Assessment. Again, the AAI has re-iterated its interest in this project. Team Lead has been requested to prepare the four square chart for presentation in the next Board meeting.

b. Study on Next-Gen/SESAR Technology Requirement for India

This is a new proposal. Team Lead has been advised to prepare the four square chart for presentation in the upcoming ACP Board meeting.
