### 3. Points of Discussion

Mr. Aaron E. Wilkins, ACP Co-Chair (Govt.) and Dr. Dinesh Keskar , ACP Co-chair (Industry) kicked-off the ACP Board meeting on Jan 28, 2011 and welcomed the ACP members and briefed about the ACP over all activities.

“**Taking ACP to the next level**” was deliberated in detail and conclusion as follows

- 3.1 Regular ACP reviews with Indian Government customers will continue to discuss the requirement as well as brief about the ACP on-going projects.
- 3.2 Project strategy meeting with ACP Co-chairs continue to exist, this is meant to discuss about on-going projects and brief about the TOR which helps to update the status of the project
- 3.3 Inviting guest speakers in ACP Board meeting – This point has been **dropped**.
- 3.4 Revised ACP “**Road-show Presentation**” is uploaded on the ACP website ([www.acp-india.com](http://www.acp-india.com)) in the “downloads” section for quick reference.

### 4. Dashboard of Projects & Proposal

Mr. Aaron, ACP, Co-Chair (Govt.) reviewed the “Project Status” and briefed to members regarding on-going project status, project under process in USTDA and project under consideration., please refer to the four square charts presented in the ACP Board meeting presentation as slide numbers given in the same with “Red Fonts”.

#### 4.1 Projects underway

**a. Technical Training for Aerospace Industry:** The status of the project is hereunder:

- i. Grant offer letter to Hi-Tec Systems for Technical Training for Aerospace Industry had been signed.
- ii. Contract Agreement between DGCA and Hi-Tec had been signed.
- iii. Fund Mobilization letter had been submitted to DGCA and expected to be signed on 16<sup>th</sup> Dec 2010 and not yet cleared due to procedural delay.
- iv. Team lead has to develop and circulate the training schedule which is awaited.

**b. Helicopter Aviation Safety Technical Assistance** – Bell Helicopter has informed to ACP Board that Bell Helicopter has completed their task and will submit the report in the month of December 2010.

- i. Final report will be submitted by Bell Helicopter in end of the month Dec 2010.
- ii. Final report being reviewed by top management of the Bell Helicopter and expected to submit shortly.
- iii. Recommendations will be reviewed by ACP Secretariat for follow-on project

**c. AAI ATCO Manpower Assessment [AAI Cost Share]:**

The Contact Agreement is ready for signature. WCG and AAI are trying to resolve the tax issue which arises due to cost share of the project. Work is expected to begin in Dec 2010.

- i. Taxation issue has been resolved by AAI.
- ii. At present contract document is being reviewed by USTDA Attorney

- iii. Commencement of work schedule will be circulated by WCG after signing the contract document with AAI.

**d. GBAS Pilot Project at Chennai Airport**

USTDA has completed the desk study and TOR has been approved by AAI.

- i. Draft Grant offer letter has been received by AAI and under review
- ii. Hardware procurement is under process by AAI

**4.2 Proposal under Processing**

**a. Technical, Management, & Operational Development Training [TMODT]:**

- i. Desk Study had been completed on Nov 17, 2010 and due-diligence completed
- ii. Letter of expression for sharing cost of travel and lodging had been received from DGCA and sent to USTDA.
- iii. The proposed new time –line has been reviewed by DGCA
- iv. Some clarifications are awaited from FAA to clear the project.

**b. Study on “Next-Gen/SESAR Technology” Requirement for India**

This project is under desk study review & AAI has shown interest to share the cost of this project. USTDA had sent request to AAI for cost share upto 20-25% of the project cost. A reply is awaited from AAI either in favor or otherwise. This project is ready for offering grant to AAI by USTDA

**4.3 Proposals under Development**

**a. ATM Processes & Procedures Implementation**

This project is follow-on project of ATM Training Program (ATMTP) and the final report had been submitted to Airports Authority of India (AAI). This project will be discussed in detail for developing TOR when WCG sign the contract for 4.1 (c) in AAI Corporate Headquarter (CHQ).

**b. Geographic Information System (GIS) platform in Indian Airports**

TOR has been submitted and presentation made to AAI on Nov15, 2010 and same had been approved. Member (ANS) has suggested adding SMS module for AAI in this project.

**In this meeting, Honeywell has shown interest to participate in this project as Team member.**

**c. AAI CNS Manpower Assessment [AAI cost Share]:**

This project is follow-on to the ATCO Manpower Assessment. Again, the AAI has re-iterated its interest in this project. This project will be discussed for developing the TOR when WCG sign the contract for 4.1 (c) in AAI CHQ.

**d. Airport Regulatory & Financing Pilot for Regional Airport**

In this meeting this project was deliberated and project Team-lead has been changed from PAS to SDG with the approval of Co-chairs. SDG representative was advice to contact USFCS Mr. Yash Kansal and Ms Lola Gulmova and discussed about this project. Based on the outcome, a meeting will be arranged with AAI for further discussion on the subject.
