Vishal S. Amin, brings over 20 years of diverse experience in civil and military aviation. Prior to returning to government service, Vishal was the Chief Executive Officer of Aertron, Inc., a veteran-owned business providing innovative transportation solutions. Vishal was also appointed by the Governor of Maryland to serve as a Commissioner on the Maryland Aviation Commission overseeing Baltimore/Washington Thurgood Marshall Airport. Prior to founding Aertron, Vishal was Chief of Staff to the Chairman of the National Transportation Safety Board (NTSB) where he led engagements with key international stakeholders such as the International Civil Aviation Organization (ICAO), the Transportation Safety Board of Canada, the Japan Transport Safety Board, and the United Kingdom Air Accidents Branch.

As the first Indian-American diplomat serving as the Senior Federal Aviation Administration (FAA) regional representative for South Asia, based out of the U.S. Embassy in New Delhi, Vishal is responsible for building strong partnerships with counterparts in the civil aviation authorities in India, Pakistan, Afghanistan, Bangladesh, Nepal, Bhutan, Sri Lanka and Maldives. Vishal is responsible for being the top FAA authority in South Asia on U.S. civil aviation, policies, practices and procedures. He is responsible for coordinating and managing aviation related activities with other U.S. Government agencies, foreign civil aviation authorities and international aviation organizations. Vishal is passionate about aviation safety and will also promote international aviation safety and efficiency, solicit support for U.S. standards, policies, and procedures that promote safety and efficiency in the global air transportation system.

Vishal began his Federal Aviation Administration (FAA) career as an air traffic controller and worked in numerous leadership roles within the FAA. Vishal is also a FAA certified Commercial Pilot and Single and Multi-engine Flight Instructor. Vishal has a Professional Certificate from the Massachusetts Institute of Technology and a Bachelor's of Science in Aeronautical Science from Embry-Riddle Aeronautical University. Vishal served four years in the United States Air Force and was also appointed to the U.S. Air Force Academy. Vishal is also multi-lingual and fluent in both Hindi and Gujarati. Vishal is happily married and is a proud father of two boys.





Mr. Thomas R. Hardy,
Director for Program Management,
U.S. Trade and Development Agency (USTDA)

Thomas R. Hardy was appointed on August 4, 2020 as the Director for Program Management of the U.S. Trade and Development Agency, a U.S. government agency that helps U.S. businesses create jobs through the export of their goods and services for priority development projects in emerging economies. USTDA links U.S. companies to global export opportunities by providing early project preparation assistance that matches U.S. technological expertise with overseas infrastructure development needs – creating lasting business partnerships between the U.S. companies and emerging market economies.

Previously, Mr. Hardy led USTDA as the Director (Acting) from 2017-2020 where he helped to transform the Agency to take on the challenges presented in an ever-changing global landscape. He has also served as the Chief of Staff and as a Country Manager in the East Asia and sub-Saharan Africa regions.

Prior to joining USTDA, Mr. Hardy served as an advisor to Commissioner Thelma J. Askey at the U.S. International Trade Commission and as a staff member of the Committee on Ways and Means in the U.S. House of Representatives.



Mr. Rajiv Bansal, Chairman & Managing Director, Air India

Senior IAS officer Shri Rajiv Bansal had taken over as the Chairman and Managing Director of Air India on 17thFebruary, 2020. On 27thApril, 2020 he has been appointed in the rank and pay of Secretary to the Government of India. Prior to his current assignment, Shri Bansal had been serving as the Additional Secretary, Ministry of petroleum and Natural Gas, Government of India. Shri Bansal had held the additional charge of Chairman & Managing Director, Air India earlier in 2017.

A 1988-batch IAS officer of the Nagaland cadre, Shri Rajiv Bansal is a Civil Engineer by profession, having graduated from IIT, Delhi in 1986. He is also qualified with a Diploma in Finance from ICFAI, Hyderabad as well as an Executive Masters in International Business from IIFT, New Delhi.

In his long and distinguished career spanning over three decades, Shri Bansal has been CEO of National Internet Exchange of India (NIXI) during 2016-17 and CEO of Investor Education Protection Fund Authority (IEPF) in 2019. Shri Bansal has served as Secretary, Central Electricity Regulator Commission, Joint Secretary in the Department of Heavy Industries and as Director in the Ministry of Civil Aviation. He has been Director on the Board of Oil & Natural Gas Corporation Limited (ONGC) and Bharat Petroleum Corporation Limited (BPCL), which are listed at ranking 190 and 309respectively in Fortune 500 Global list of 2020. Apart from this, he has also been on the Board of Bharat Heavy Electricals Limited (BHEL), National Aviation Company of India Limited (NACIL)-(earlier name of Air India) and Alliance Air and other organizations. He also held key assignments in the State Government of Nagaland during his stint in the state.





Dr. Shefali Juneja, Representative to India, International Civil Aviation Organization (ICAO)

Dr Shefali Juneja took over on was appointed on August 28, 2019 as the Representative of India on the Council of International Civil Aviation Organization in Montreal, Canada. ICAO is a specialized UN Agency, that regulates international aviation. Governed by the Chicago Convention of 1944, it provides standards and regulations to its 193 Member States and Aviation industry. Previously, Dr Shefali was Joint Secretary in Ministry of Civil Aviation dealing with International Agreements (2012-2019). She was the chief bilateral air services negotiator for India for 6 years and she helped to transform the bilateral air service negotiations by implementing Open Skies as per the National Civil Aviation Policy 2016. She has served as the Board of Director in Air India group companies namely-Air India Express and Alliance Air. She has worked as a Director in the Ministry prior to her alleviation serving in Finance, Economic Regulation, Aviation Security and Air India divisions. With an MBA in Aviation Management and Certificate Course from McGill University in Aviation law, Dr Juneja brings a rich practical and theoretical knowledge in Aviation.

Prior to joining Ministry of Civil Aviation, Dr Shefali, has served on many sensitive and challenging assignments, semi-judicial positions and administrative and financial positions in the government as a civil servant, belonging to the Indian Revenue Service, 1992 batch.
